Definitions

1. **Event** – refers to the gathering of participants for Taekwondo related activity, involving more than one member club, and is not limited to the following: seminars, training camps, sparring exchanges, cross-training and tournaments.
2. **Tournament** – refers to the gathering of participants for Taekwondo competition involving more than one member club, in accordance with Taekwondo Ontario (TO) and/or World Taekwondo (WT) competition rules and regulations, in which an award is granted to the winners. For the purposes of this policy, a tournament is deemed a contest in the context of the Order in Council.

For the purposes of this policy, the tournaments are further classified into the following categories:

Category	Description	Participation
P	Provincial selection tournament run by the PSO in which only PSO members with Canadian residency can participate in the competition.	Open to PSO members only
A	Open tournament where PSO members and non-members are invited and accepted by the host to participate in the competition.	Open to non-members and PSO members.
B	Open tournament where PSO members and non-members are invited and accepted by the host to participate in the competition, but the host agrees to share the costs for hosting a one-day Category P tournament the next day by providing mats and venue to the PSO at no cost.	Open to non-members and PSO members.
C	Open tournament where PSO members and non-members are invited and accepted by the host to participate in the competition. This category is for hosts that are running a competition for the first time or hosts that have not met the criterion to hold a Category A tournament.	Open to non-members and PSO members.

D	Inner-school tournament restricted only to the host club's members and branch school members. Any PSO member or non-member not belonging to the host club or the host club's branch schools are not permitted to participate. A host is automatically granted a Category D sanction upon email notification to the PSO at least 60 days prior to the inner-school tournament date. F	Fundraising tournament, run by the PSO and/or in conjunction with a sponsor, open to all PSO members and non-members, in which a revenue percentage of the tournament proceeds are donated back to the PSO. The minimum portion of donation back to the PSO required to hold a Category F tournament is \$7,500 CAD.	Open to non-members and PSO members.
N	National tournament hosted by the NSO in the Province of Ontario in which the participation requirements and audience are dictated by the NSO.	Determined by NSO.

3. **Contest** – is defined as a competitive event or exhibition where:
 - Spectators are admitted, expressly or by implication, for a fee or for free; or
 - Athletes are required to directly or indirectly pay a fee to participate; or
 - The event is recorded for commercial broadcast; or
 - Any other circumstance prescribed by the ministry.
4. **Member** – all categories of membership defined in the TO bylaws.
5. **Non-Member** – any person that does not have a membership with TO.
6. **Participant** – any member or non-member participating in a TO sanctioned event.
7. **Member Club** – any club resident in the Province of Ontario that that holds membership in good standing with TO.
8. **Non-Member Club** – any club that does not have a club membership with TO.
9. **Host** – an organization or member club that is hosting and/or organizing an event.
10. **Provincial Sport Organization (PSO)** – are not-for profit organizations formally recognized by the Ministry of Tourism, Culture and Sport as the governing body of a particular amateur sport in Ontario. Taekwondo Ontario (TO) is the PSO recognized by the Province of Ontario to govern the sport and martial art of Taekwondo and sanction all Taekwondo events.

11. **National Sport Organization (NSO)** – (sometimes referred to as National Sport Federations (NSFs), are the national governing bodies for their sports in Canada recognized by the Government of Canada.
12. **Sport Recognition Policy (SRP)** – sets out mandatory requirements that all PSO/MSOs must meet in order to be recognized by the Province of Ontario.
13. **Combative Sport** – A sport that features a contest where participants use striking with fists, hands, feet or any other part of the body, throwing, grappling, wrestling, immobilization or submission techniques, or any combination of these techniques.
14. **Fee Schedule** – the fees associated with obtaining an event sanction through the PSO and is set and approved by the Executive and Board of Directors on an annual basis.
15. **Medical Support Team** – a medical team consisting of a licensed physician from Ontario and a multi-discipline medical crew adequate to safely administer treatment for competitors at a sanctioned event.
16. **Conditional Sanction** – refers to the provisional granting of a tournament or event sanction to a Host by the PSO which is subject to the Host meeting the requirements of the policy. This includes the Host having the minimum number of members required for the respective Category as at August 31st preceding the beginning of season on September 1st of the same year. Failure to meet the requirements of the policy, including the minimum members for the respective Category, will result in the sanction being revoked by the PSO.
17. **Participation Cap** – the number of participants is limited to a maximum number to ensure that the event can be run in a safe manner.

Purpose

As the recognized Provincial Sport Organization (PSO) governing the sport and martial art of Taekwondo in the Province of Ontario, Taekwondo Ontario (TO) is committed to ensuring that all Taekwondo related events are conducted in an environment that promotes safe, standard and fair competition and where applicable, in accordance with the Province of Ontario's requirements for sanctioning a combative sport contest.

The purpose of this policy is to provide clarity on the requirements and process to apply for PSO event sanctioning through TO.

Scope

This policy applies to all Hosts of an event applying for sanctioning from TO.

Responsibility

1. The 2nd Vice President is responsible for maintaining and updating this policy.
2. The Board of Directors is responsible for reviewing and approving this policy.
3. The Host is responsible for reviewing the policy and applying for event sanctioning. Upon conditional granting of the sanction, the host is responsible for ensuring all requirements are fulfilled leading up to, during and post the event.
4. The Executive Director or a person appointed by the Executive is responsible for reviewing the Host's submission for event sanctioning for completeness and forwarding the application to the Event Sanctioning Committee.
5. The Event Sanctioning Committee is responsible for scheduling of events for TO. Additionally, the Event Sanctioning Committee is responsible for reviewing, granting or denying the sanctioning of events in accordance with the policy.
6. The Executive Committee is responsible for the final interpretation of this policy should any questionable matter or discrepancies arise, or for items not covered in this policy.
7. The Tournament Chair or designate is responsible for observing and evaluating a sanctioned event in accordance with the policy.

Policy

1. Through an Order in Council (1087/2017) effective July 1, 2017, the Government of Ontario has designated 11 amateur sports in which contests are now legal if held with the permission of a government-recognized Provincial Sport Organization (PSO). Taekwondo Ontario (TO) is the designated PSO governing Taekwondo contests in the Province of Ontario.

GENERAL INFORMATION (APPLICABLE TO ALL CATEGORIES EXCEPT CATEGORY D)

2. **Event Season** – The event season to hold tournaments for TO begins September 1, 201X to the August 31, 201Y of the subsequent year.
3. **Application Period**
 - a. **Tournaments** – The event sanctioning application period for **ALL** tournaments (excluding Category D, Category P, Category N and Category I) is due midnight of January 31, 201X by the prospective Host, through the taekwondo-ontario.com website portal for the upcoming September 1, 201X to August 31, 201Y season.
 - b. **Other Events** – The event sanctioning application period for all other events including Seminars and Training Camps, open to more than one TO member club in addition to the Host club's branch schools, must be submitted online no later than 4 weeks, in advance of the event date through the taekwondo-ontario.com website.
4. **Prioritization** – All Category P, Category N and Category I tournaments will have priority over all other Category tournaments in accordance with Appendix 3 and are not be subjected to the Event Proximity Date between tournaments provided it is not the same date as another Category tournament event.
5. **Medical** – In accordance with the SRP, a licensed physician must be present and in close proximity for the duration of all high-performance divisions with strikes to the head for all Category tournament events. During the divisions with full contact to the body, but without strikes to the head, a licensed physician is not required but medical personnel consistent with the industry standard must be present. Similarly, in all seminars and training camps in which there is full contact, medical personnel consistent with the industry standard must be present.
6. **TO Membership Requirement** – All participants residing in Ontario participating in a sanctioned TO event (tournament or event), must be members in good standing of TO to ensure that they are adequately insured. Participants residing outside of Ontario must purchase a one-day pass through the TO Event Registration Portal (ERP) or provide proof of insurance.
7. **TO Event Registration Portal & Event Administration Module** – The Event Registration Portal (ERP) is a website portal that allows individuals to register for TO sanctioned events. The Event Administration Module (EAM) including the ERP will be provided to each Host who is granted an event sanction. The Host of the event will have full access through the EAM to view and adjust participants competing in their event as required prior to the close of registration.

8. **Venue** - The Host of the tournament must ensure that the venue meets the following requirements:
- Has clearly marked and unobstructed exits.
 - Meets and abides by any local building and fire regulations.
 - Contains proper ventilation and temperature control.
 - Contains adequate sanitary washrooms and change room facilities.
 - Contains adequate space for a sorting area, warm-up area and a minimum number of fully operational rings based on the divisions offered in the tournament as outlined in Appendix 1 of the policy.
- Appendix 2 of the policy contains a list of venues that have been pre-approved to host Category A, Category B, Category C and Category F tournaments. Any venues used outside of the pre-approved venue list will require the written assessment of the Tournament Chair and Referee Chair and approval of the Event Sanctioning Committee.
9. **Minimum Rings** – The Host of a Category A, Category B or Category C tournament must ensure that there are adequate mats to operate minimum number of rings based on the category of divisions offered in accordance with the table in Appendix 1 of the policy.
10. **Officials Meals & Snacks** – The Host of a tournament must ensure that there is a lunch room and that lunch is provided for the care and comfort of the volunteers, officials and Medical Support Team. Additionally, the Host must ensure that each ring is adequately stocked with water and snacks for officials.
11. **Display Booth** – Member clubs hosting a tournament must ensure that there is adequate space in a prominently visible location inside the venue for TO to setup a 10 ft. x 10 ft. booth to promote programs and benefits of the PSO.
12. **Protector Scoring System (PSS)** – For all High Performance Kyorugi divisions of TO sanctioned tournaments, the recognized WT PSS must be used as shown in accordance with Appendix 4 of the policy.
13. **Poomsae Competition Scoring System (PCSS)** – For all High Performance Poomsae divisions of TO sanctioned tournaments, the recognized WT PCSS must be used as shown in Appendix 4 of the policy.
14. **Evaluation** – The Event Sanctioning Committee, based on the scope and authority outlined in the committee’s Terms of Reference (TOR), will have the authority to schedule, grant or deny any event sanction based on the evaluation criteria as shown in Appendix 3 of the policy.
15. **Appeals** – Should a prospective Host not agree with the decision of the Event Sanctioning Committee regarding sanctioning of a tournament, they may file an appeal in writing via email to the Appeals Committee no later than 14 days of the days from the time they were notified of the decision. Appeals submitted after the 14 days timeframe will not be heard.

16. **Province of Ontario Endorsement** - Once an event or tournament sanction has been granted by the TO Event Sanctioning Committee, the Host must ensure that the Taekwondo Ontario and Ontario Trillium logos along with the following text “THIS CONTEST IS SANCTIONED BY TAEKWONDO ONTARIO, THE PROVINCIAL SPORT ORGANIZATION (PSO) OFFICIALLY RECOGNIZED BY THE PROVINCE OF ONTARIO.” is prominently displayed on all posters and tournament packages for the approved sanctioned event or tournament only. No modifications can be made to the text or logos.

CATEGORY A / CATEGORY B / CATEGORY C TOURNAMENTS

17. All prospective Hosts interested in hosting and obtaining event sanctioning for tournaments, with the exception of Category D, P, N & I, must meet the requirements as listed in Appendix 1 of this policy. The granting of event sanctioning for tournaments is conditional upon the Host fulfilling the requirements of the policy. The requirements include the following:
- a. **Club Membership** – All prospective Hosts, with the exception of the PSO, NSO, PATU or WTF, looking to host any category of tournament or event must have a valid club membership in good standing with TO at the time of the application and also a renewed club membership at the beginning of the (201X-201Y) season on September 1, 201X.
 - b. **Minimum Member Requirements** – In accordance with Appendix 1 of the policy, all member clubs looking to obtain event sanctioning to host a tournament must meet the minimum number of members per location. As the sanction provided by TO to a prospective host is conditional upon fulfilling the minimum member requirements, failure to do so could result in cancellation or forfeiture of the tournament and the host granted the conditional sanction is responsible for all costs incurred including early cancellation penalties. Each location refers to a branch club location outside of the main school owned by the same club owner as per the Master Business License or the Articles of Incorporation.
 - c. **New Club Members** – New member clubs registering with TO will be ineligible to apply for tournament event sanctioning until they have been a club member in good standing for at least a period of 1 year upon joining.
 - d. **First Time Hosts** – Member clubs hosting a tournament for the first time will only be eligible to apply to host a Category C tournament.
 - e. **Date Changes** – Once a conditional sanction is granted to a host, date changes by the hosts are subject to availability and will adhere to the event proximity date requirements.
 - f. **Standardized Tournament Package** – To ensure consistency across all Category tournaments with the exception of Category D, P, N & I, the Host will use the standardized tournament package template provided by TO along with the tournament competition schedule. The package will include the mandatory uniforms and equipment required for each event category and division.

- g. **Participant Registration** – All participant registration will be through the Taekwondo Ontario Events Registration Portal (ERP). The final registration list for the tournament will be generated through the Event Administration Module (EAM) by the Tournament Chair and provided to the Referee Chair to ensure that last minute registrations are not accepted. The Host will have full access to view and edit existing registrations, but they will not be able to manually add registrants once registration is closed.
- h. **Weigh-Ins** – All participants of the tournament competing in sparring divisions must be weighed on the day of competition, prior to bracketing. The list of participants will be based on the final list generated through the EAM by the Tournament Chair.
- i. **Minimum Host Club Referees** – The Host of a Category A or Category B tournament must contribute a minimum of 10 referees certified at the provincial level or above from their own club to officiate at the tournament. The referees will per paid in accordance with the Taekwondo Ontario Fee & Honorarium Schedule. The Host of Category C tournament must contribute a minimum of 5 referees certified at the provincial level or above from their own club to officiate at the tournament. The names of the referees must be provided to the Referee Chair by the Host no later than 4 weeks prior to the tournament date.
- j. **Rules** - All Category A, B and C tournaments will follow Taekwondo Ontario modified rules for color belt and recreational black belt divisions. All high performance divisions will follow WT rules and regulations.

CATEGORY D TOURNAMENTS

- 18. A Host interested in hosting a Category D inner-school tournament must notify the Event Sanctioning Committee via e-mail a minimum of 60 days prior to the event date. Upon doing so, a sanction will be automatically granted. Participation by a PSO member or non-member outside of the host club or host club's branch is a deemed a violation of the Event Sanctioning Policy and subject to disciplinary action.

CATEGORY F / CATEGORY P / CATEGORY N / CATEGORY I TOURNAMENTS

- 19. All Category F tournaments, will be hosted by the PSO and/or in conjunction with a sponsor.
 - a. **Standardized Tournament Package** – Category F tournaments will use the standardized tournament package template provided by TO along with the tournament competition schedule. The package will include the mandatory uniforms and equipment required for each event category and division.
 - b. **Participant Registration** – All participant registration of Category F tournaments will be through the Taekwondo Ontario Events Registration Portal (ERP). The final registration list for the tournament will be generated through the Event Administration Module (EAM) by the Tournament Chair and provided to the Referee Chair to ensure that last minute registrations are not accepted. The Host will have full access to view and edit existing registrations, but they will not be able to manually add registrants.

- c. **Weigh-Ins** – All participants of the tournament competing in sparring divisions must be weighed on the day of competition, prior to bracketing. The list of participants will be based on the final list generated through the EAM by the Tournament Chair.

- 20. All Category P tournaments will be hosted by the PSO and is not subject to approval by the Event Sanctioning Committee. Category P tournaments will follow WT rules and regulations.
- 21. All Category N & I tournaments will be subject to the approval of the Event Sanctioning Committee and follow their respective organizational guidelines. The safety requirements outlined in the SRP must be followed for all contests, only those with strikes to the head have additional requirements.

Implementation

For the first time implementation of this policy, the following deviations from the Event Sanctioning Policy specified below will be allowed only in the 2018-2019 season.

- 1. **Application Period for Tournaments** – The event sanctioning application period for ALL tournaments (excluding Category D, Category P, Category N and Category I) is due midnight of July 15, 2018 by the prospective Host, through the taekwondo-ontario.com website portal for the upcoming September 1, 2018 to August 31, 2019 season.
- 2. **Minimum Member Requirements** – The minimum member requirements of the prospective host club applying for a sanction during the implementation year is based on the following requirements below as at August 31, 2018:

Implementation Year (2018-2019 Season)	
Category A	Minimum of 75 members
Category B	Minimum of 75 members
Category C	Minimum of 50 members

As the sanction provided by TO to a prospective host is conditional upon fulfilling the minimum member requirements, any prospective hosts applying for a Category A or B tournament who fails to meet the minimum member requirements as at August 31, 2018 will be downgraded to a Category C provided they meet the minimum requirements. Any prospective hosts who fails to meet the Category C requirements will have their conditional sanction revoked and forfeit their tournament. The prospective host who forfeits their tournament by failing to meet the minimum member requirements is responsible for all costs incurred including early cancellation penalties. Each location refers to a branch club location outside of the main school owned by the same club owner as per the Master Business License or the Articles of Incorporation.

3. **Minimum Host Club Referees** – The minimum number of Host club referees to be provided during the implementation year is as follows:

Policy Review

This policy will be maintained by the 2nd Vice President and reviewed and approved by the Board of Directors at minimum every two years.

CRITERIA FOR SCHEDULING AND GRANTING EVENT SANCTIONING (CATEGORY A, B, C TOURNAMENTS)

Criteria	Description
1	Is the application submitted by the Host complete and timely in accordance with the established deadline?
2	Is the Host requesting the event sanctioning a member in good standing with Taekwondo Ontario at the time of the submission?
3	Has the Host applying previously failed to fulfill any of the requirements leading up to the tournament resulting in a forfeiture and/or cancellation of the conditional event sanction granted?
4	Has the Host knowingly run a tournament without an event sanction from Taekwondo Ontario?
5	Has the Host applying previously failed to fulfill the requirements stipulated in the agreement after the event sanction was granted during the tournament? i.e. <ul style="list-style-type: none"> • Non-compliance with the Event Sanctioning Policy; • Allowing non-members, resident in Ontario, to compete without insurance; • Inadequate volunteers and staff to run the event; • Inadequate security barriers and security to prevent spectators from the competition area; • No licensed physician on-site; • Inadequate Medical Support Team; • Non-compliance with the tournament schedule provided; • Inadequate referees provided from the Host's club; • Inadequate water and snacks and/or meals for officials; • Inadequate mats to operate minimum number of rings; • Including disciplines outside of those for which TO is approved by the Province of Ontario.
6	If the first-choice date requested by the Host conflicts with the date for any scheduled Category I, Category N or Category P tournament, defer to the Host's second choice date.
7	If the first choice or second choice date requested by a Host conflicts with the requested date of another Host, the Host of the member club with the greater number of registered members as at the submission date of January 31 st will have precedence.
8	If the first choice or second choice date requested of the two Hosts conflict, and both hosts have an equal number of registered members as at the submission date of January 31 st , the individuals who submitted the completed application first will have precedence.
